I certify that I am a Marco Island resident, and in support of this application, I AM SUBMITTING HEREWITH PROOF that I qualify for membership by including legible copies of **one of the following** with my application:

- k Copy of 2011 proposed tax statement or 2011 tax bill or 2011 homestead exemption card for **improved** residential dwelling on Marco Island showing the street address. OR
- k Copy of current homeowner's, wind, or flood insurance policy for my residential dwelling on Marco Island, showing the street address. OR
- k Copy of current condominium maintenance fee billing for my residential dwelling showing the Marco Island street address. OR
- k **New property owners:** copy of warranty deed or copy of closing statement.
- k **Annual Renters:** copy of current lease showing Marco Island street address, dates of rental period and property owner's name.

k **For members wishing to permanently affix decals to their vehicles:** License plate numbers appear on Residents' Beach decals. Therefore, **I AM ALSO SUBMITTING a copy of current vehicle registration in my name (up to two vehicles).** *If either vehicle is leased and your name is not shown on the car registration, please also submit copies of the lease or insurance card showing your name.* Vehicle titles will not be accepted.

k **I also wish to join the Marco Island Civic Association, therefore, enclosed is an additional \$30, for a total of \$160. (MICA membership is \$35. There is a \$5 discount given when Residents' Beach & MICA memberships are purchased simultaneously).**

ONLY THE ABOVE DOCUMENTS WILL BE CONSIDERED AS ACCEPTABLE PROOF OF RESIDENCY. ORIGINALS WILL NOT BE RETURNED TO YOU.

I understand that: 1) Residents' Beach membership will be granted only to natural persons (not corporations or trusts); 2) not more than one membership will be issued to any resident; 3) membership is non-transferable; 4) members entering Residents' Beach without a decal affixed to their car (decal must match license plate) must present photo identification to the gate attendant; 5) there is no refund of fees; 6) the fee to replace a car decal is \$25.00; 7) by supplying my email address, I authorize MICA to email me information. As a member of the Residents' Beach I waive for myself and any of my guests any cause of action that may arise for damages of any kind and matter. I understand that any violation of membership rules and beach access regulations will be grounds for cancellation of my membership. Under penalties of perjury, I declare that I have read the foregoing application and that the facts stated in it are true.
